NOTICE OF A CHANGE IN THE TARIFFS OF Yampa Valley Electric Association, Inc. (“Association”), with a principal place of business at 2211 Elk River Road, Steamboat Springs, Colorado 80487. You are hereby notified that the above-named Association proposes to make the following substantial revisions to its Tariffs, to become effective March 1, 2023:

1. **Sheet No. 04, Small General Service: increase system access charge to \$45.00, energy charge to \$0.11100 per kWh, and add idle service charge of \$22.50;**
2. **Sheet No. 06, Medium General Service: increase system access charge to \$60.45, energy charge to \$ 0.10650 per kWh, and add idle service charge of \$30.23**
3. **Sheet No. 08 Irrigation: increase system access charge to \$740.00 and HP charge to \$8.86;**
4. **Sheet No. 25B, Street Lighting Service, increase monthly service charge to the following amounts: (i) Roadway \leq 50 Watt LED to \$24.40; (ii) Roadway \leq 150 Watt LED to \$27.24; (iii) Roadway \leq 250 Watt LED to \$31.86; (iv) Decorative I Roadway LED 100W to \$36.64; (v) Decorative II Roadway LED 100W to \$41.19; (vi) 175 Watt Non-LED Roadway to \$17.11; (vii) 250 Watt Non-LED Roadway to \$23.62; (viii) 100 Watt Non-LED Decorative Roadway to \$24.01; (ix) 250 Watt Non-LED Decorative Roadway to \$35.17; (x) 400 Watt Non-LED Roadway to \$29.43;**
5. **Sheet No. 05 Outdoor Area Lighting Service, increase monthly service charge to the following amounts: (i) 175 Watt Non-LED Area Light to \$17.11; (ii) 250 Watt Non-LED Area Light to \$23.62; (iii) 400 Watt Non-LED Area Light to \$29.43; (iv) 50 Watt LED Area Light to \$19.24; (v) 125 Watt LED Area Light to \$26.82;**
6. **Sheet No. 07, Large General Service: increase energy charge to \$ 0.09644 per kWh and add idle service charge of \$57.50.**

Anyone who desires to complain about the proposed changes shall file a written complaint with the Association at 2211 Elk River Road, Steamboat Springs, Colorado 80487 at least ten (10) days before the proposed effective date.

The Association may hold a hearing to determine what changes will be authorized. The changes ultimately authorized pursuant to such hearing may or may not be the same as those proposed and may include changes different than those tariffs proposed or currently in effect. Anyone who desires to receive notice of hearing, if any, shall make a written request therefor to the Association, at the above address, at least ten (10) days before the proposed effective date.
